have not mentioned and specially withed.

Item 6th I will to Benjamin Meyers my son by a former wife my wife
Susan and to my infant son I will my share of land.

Item 7th If there is any thing left from sale of other property mentioned
in this will I give it to my two said sons Benjamin Meyers and John Meyers.
