Inferior Court for said County sitting for Ordinary
purposes and their successors in office in the just &
full sum of Ten thousand dollars (\$10,000), for the payment
of which sum to the Justices as aforesaid and their
successors in office, we bind ourselves our heirs
executors and administrators, in the whole and for the
whole now jointly severally and firmly by these
presents, Seals with our seals and date this 13th
day of January 1854.

The condition of the above obligations
is such that if the above bound Chas L Galt
Administrator of the Estate Real and personal of
Baby Galt late of this County deceased do
make a true and perfect inventory of the Estate
both Real and personal of said deceased which
shall or has come into the hands possession or
knowledge of the said Chas L Galt or in to the
hands possession of any person or persons for
him and the same so made do exhibit to the
said Court of Ordinary when (called on) he shall
be thereto required and such estate do well and
truly administer according to law and do make a
true and just account of all his actings
and doings therein when he the said Chas
L Galt shall be thereto required by the
Court of Ordinary for said County and all
the rest of the said estate which shall be
found remaining upon the account of the ad-
ministration the same being first allowed by the Court
shall deliver and pay to such person or persons
respectfully as are entitled to the same by law and
if it shall hereafter appear that any last will and testament
was made by the deceased and the same be proved before the Court
and the executors obtain a certificate from the
probate thereof and the said Chas L Galt do in
such case if required render and deliver
up the said letters of administration

then this obligation to be void. Else to remain in full
