LAST WILL AND TESTAMENT OF JOHN MCCONNELL, JR

In the name of God, Amen, I, John McConnell, of the County of Cherokee and State of Georgia, being of sound mind and memory and considering the uncertainity of this frail and transitory life, do therefore make, ordain, publish and declare this to be my last Will and Testament, that is to say, first I desire that my body be buried at the Hickory Flat burying ground, in a decent and christian-like manner and that such monument be erected over my grave as circumstances in life and the situation of the country will permit, this be done by my executors hereinafter named. Second, I desire that all of my just debts be paid out of my effects as soon

as the same can be done after my death.

Third, to my wife, Brances McConnell, I give and bequeath and desire that she have all the household and kitchen furniture, farming tools and other personal property that she had at the time of my marriage with her, as I do not wish my heirs to have any of her property. I also give and bequeath to my said wife, and direct as soon after my death as the same can be done, sixty bushels

LAST WILL AND TESTAMENT OF JOHN McCONNELL, Jr. - continued of corn, ten bushels of wheat, seven hundred pounds of pork, also one sow and pigs, also one cow and calf and one yearling calf. I also disclaim any right or title to the negroes belonging to my wife, to-wit Caroline and her children, and it is my Will and desire that they remain as they were at the time of my marriage with her.

Fourth, I desire and direct that my negroes, Green, a man about forty-seven years old, and Biddy, a woman about sixty-five years old, Mary Ann, about twenty-five years old. David, a man about forty years old, Sam, about thirty. five years old, Dick, about thirty years old, be put and sold to the highest bidder - the three last named negroes supposed to be in the hands of the Yankees, to be sold as soon as practicable in case they are recovered. Fifth, it is my Will and desire that all my land whereon I now live, together with all my stock of horses, mules, cattle, sheep and hogs be disposed of at public sale as soon as practicable after my death and that the sale of my property shall take place at the place of my present residence. Sixth, it is my Will and desire that after the payment of all my just debts and all expenses incurring in the management of my estate, that my executors make an equal division to the following named heirs, viz., James McConnell, Henry McConnell, Sr., Samuel M. McConnell, Nancy Putnam, wife of Daniel Putnam, Mary Ann Roberts, wife of Joshua Roberts, William McConnell, Isaac McConnell, and Joshua McConnell, the children of Joseph McConnell deceased. Also the children of Sarah Paine deceased formerly the wife of Thomas I. Payne, the share here bequeathed to the children of Sarah Payne is to be equally divided between her two unmarried children, to-wit: William H. Payne and Martha Ann Payne.

Seventh, I am induced to leave out from any provision in this my last Will, the children of my son, Eli McConnell, for the reason that I have long since in the life time of the said Eli McConnell divided my estate liberally with him, and his said children which are now amply provided for.

LAST WILL AND TESTAMENT OF JOHN McCONNELL, Jr. - continued Eighth, likewise I make, constitute and appoint my two sons, Isaac McConnell and Samuel McConnell, to be executors of this my last Will and Testament, hereby revoking all former Wills by me made.

Ninth, It is my Will and desire that all of my household and kitchen furniture, my farming tools, wagon, buggy and all other property belonging to me at the time of my death be sold and the proceeds of the same divided equally among my heirs as designated and named in the sixth item of this Will. And also all money that I may have on hand at the time of my death be divided to my heirs in the same manner, and to that same persons as mentioned in the said sixth item of this Will, in witness whereof I have hereunto subscribed my name and affixed my seal, this the 9th day of June 1865.
