Clarke County I Edward P. Bishop, by the grace
of God Amen,

I, Edward P. Bishop of Athens in the County & State
aforesaid, being of sound mind and despatching memory,
and recognising the uncertainty of life and the certainty
of death do make & publish this my last Will & Testament
in manner and form as follows:

Item 1st

I give, bequeath, & devise to my beloved wife Martha
M. Bishop One third of my estate real, personal, & mixed
to have & to hold to her & her heirs for ever in fee simple.

Item Second

I give, bequeath, & devise to my five children Mary Burton,
Edward Thomas, Helen Louise, Lucy Marion, & the infant
son not yet named, all the rest and residue of my estate real,
personal & mixed, Share and Share alike, but the same is to be
kept together & held in common by their mother hereinafter
named as Executrix and paid to them as they are married or
arrive at age, and not before, it being my desire that when
a child receives a share the remainder shall still be in common
till the next child receives a share & so on to the last & youngest
child. It is also my Will that any & all children hereafter
born to me shall be counted & considered as the five children
already born & partake equally with them, and should any
of my children now born or hereafter born die before marriage
or arriving of age the share of such deceased child is to fall
back into the common estate & the division to be made among
the remaining children as they may or arrive of age as aforesaid,
any brother or sister being of age or married to participate in the
legacy of such deceased minor.

Item Third

I nominate and appoint my beloved wife Martha M. Bishop
Sole executrix of this my last will & testament, hereby revoking
all other Wills heretofore made by me, and I constitute and
appoint her testamentary Guardian of all my children born & to
be born and I hereby empower her to dispose of any part of my estate
real & personal & make good & sufficient titles to the purchases as my
executrix and I relieve her from all impeachment of waste
and from the necessity of public sales and making returns to
the Ordinary, having full confidence in her sound discretion
and prudence in the management of the estate.
