I Mary Wells do make this my last Will and Testament: I give and bequeath to my afflicted and beloved Sister Martha Jane and Amanda Day all my Real Estate to which one House and lot on main St. Athens and three shares of Athens Market Stock to be held in trust for them and their use each sharing alike in the benefit and I hereby appoint Robt. L. Bloomfield my Executor to execute the above my last Will and Testament. Now should I linger long in my sickness and cause expense which my Estate could not pay without selling the above property then my Executor will keep control of the property until the income has paid all my lawful debts. Now I further provide that should either of the above named sisters die then the remaining sister will receive all the profits arising from the property and at the decease of the last surviving sister then I desire the above named property to be equally divided between my surviving Brothers and Sisters and should it so happen that all my Brothers and Sisters were deceased then I will the above property to be divided between all my surviving Nephews and Nieces Share & Share alike.

I Lucia L. Mitchell, wife of William L. Mitchell, of Athens, in the County & State aforesaid, of sound and disposing mind and memory, and sensible of the uncertainty of life, and the certainty of death, do make and publish this my Last Will and Testament in manner and form as follows:

Item 1. I desire to be buried in Oconee Cemetery on my husband's Cemetery lot in such manner as is appropriate, and becoming a member of the church, and according to the usage of the Presbyterian People, when ever it shall please God to take me to himself, trusting that my body will rest in hope to be raised up at the last day, and reunited to my soul to live forever in the Holy City of the Blessed Saviour and Redeemer, and sanctified by the Holy Spirit, Amen.

Item 2. My only child is Henry B. Mitchell, to whom, with the full consent and approbation of my husband, I will, and give, and bequeath all my estate and rights of property of every kind, including notes, bonds, and other choses in action, a portion of which amounting to more than two thousand dollars is in the hands of my brother Lucian O. Bass of Colebrook in the State of Connecticut, who has generally managed the same without commission, or other compensation; and the remainder is in the hands of my husband as my trustee as will appear by reference to our marriage agreement bearing date November 20. 1864. and a subsequent agreement or indenture bearing date November 2. 1866. The right I hereby will to my son is absolute and to him and his heirs in fee simple forever.

Item 3. I nominate and appoint my son Henry B. Mitchell, executor of this my last Will and Testament, praying the blessing of Heaven upon him, that he may have grace to act wisely, and to me what I have given him with prudence, and to the glory of God.
