I, Susan Wheabee, of said county, being of sound & disposing mind and memory, but of advanced age, do make, publish and declare the following as my last Will and Testament, hereby revoking all former Wills and Testaments made by me;

Item 1 - If I should owe any debts at the time of my decease, I direct that none of my property shall be sold, but that my Executors hereinafter named pay the same out of the hire of my negroes and any monies that may be due me, and to this end my said Executors are authorized to retain possession of my negroes and hire them out until such debts can be paid, and until their commissions and all other expenses of administration are paid out of said hire.

Item 2 - I give and bequeath to my esteemed friend, Doctor Norman L. Chester his heirs and assigns, the following named negroes, and all their future increase from this date, namely: Lavinia, Frances, and Indiana, daughters of Lavinia, and Lucy, also her daughter, and Richard, her son, Laura, Kenny and Mary Ann and Letty Eugenia, daughter of said Mary Ann, in trust for the sole and separate use and benefit of my daughter Mary J. Keath, during her natural life, and after her death, to her children, share and share alike.

Item 3 - I give and bequeath to my said friend, Norman L. Chester, his heirs and assigns, the following named negroes, and their future increase from this date, namely: Lucy, Elizabeth, George, Sumus and Antoinette, and also a claim I have pending in the Superior Court of Fulton county, against the Western & Atlantic Rail Road for the killing of my negro man Cicero by the cars, in trust

for the sole and separate use, and benefit of my daughter Julia M. B. B. during her natural life, and at her death, to the use, and benefit of her children share and share alike.

Item 4 - I give and bequeath to my daughter Julia M. B. B. my house and lot in the city of Macon, Georgia, whereon I now reside, and all its appurtenances; and also the following negroes, namely, with all their future increase, from this date - Betty, Randall, Thomas, Eugene, Judy, and the following children of Betty, namely, Sally, Ann, Pearl and Lelaine.

Item 5 - I give and bequeath to the said Norman S. Chester his heirs and assigns all my household goods, furniture and assets of every kind, whatsoever, not herein otherwise bequeathed, in trust for the sole and separate use of each of my said daughters during their natural lives, and then to their children respectively inheriting per stirpes and not per capita.

Item 6 - I hereby nominate my esteemed friends, Norman S. Chester and William Root, as Executors, and beg them to accept and act. In testimony whereof, I have hereto set my hand and seal.
