I do therefore make this my last will and Testament hereby Intaking annulling all other by me heretofore made my first. I desire and direct that my body be buried in a decent and Christian like manner suitable to my circumstances and condition in life my soul I trust shall return to rest with god who gave it and for salvation through the merits and atonement of the Blessed Lord and savior Jesus Christ

Beyondly I desire and direct that all my just debts be paid without delay by my Executor herein after named and appointed. I hereby I give bequeath and devise to my Grand Son John Marshal Ashley one Grey Horse with all the Tack members and appurtenances thereto Belonging to said Grey Horse Free from all charge or Limitation whatever to his own proper use Benefit and behoof for ever

Fourthly I give bequeath and devise to my Grand Son Nathaniel Ashley Esq of Land No 346 Three hundred & forty six situated lying and being in the first District of Originally Spring now of Coffee containing One hundred & ninety Acres (490) with all
