and publish this my last will
and testament in manner and
form following to wit:

during my existence in this
changeable and uncertain life

Item 1st My will is that all
my just debts be paid if
any I owe at the time of
my death and that I be
buried in a manner suit-
able to my condition in
life

Item 2^d I give bequeath and
devise to my beloved grandson
J. M. Ashby the following real
property to wit: Lots of land
numbers (281) Two hundred and
eighty one and (293) Two hundred
and seventy two lying and
being in the original first
district of the County of Appling
now in the County of Coffee
aforesaid containing (290)

✓ four hundred and ninety acres more or less, each and both together containing (980) nine hundred and eighty acres to have and to hold unto the said J. M. Ashley and his heirs forever and to their own proper use benefit and behoof.

Item 3^d I give and bequeath to my said grandson J. M. Ashley the following personal property to wit: All my cattle now in my possession marked straight split and under bit in one ear and under bit in the other ear and branded with a cross And all other cattle that I shall own or possess in my own right at the time of my death; And all my hogs marked with a cross and split in one ear and all the hogs I shall own or possess in my own right at the time of my death; And one dark blood horse now in my possession named, Thightingale; and one buggy and one horse cart now in my possession; And all my household and kitchen furniture of every class and description to his own proper use benefit and behoof.

Item 4th I give bequeath and devise unto my said grand son J. M. Ashley all my property both real and personal and mixed of every kind class and description that I shall own have or possess at the time of my death.

Item 5th I hereby appoint Joseph J. Lewis executor of the my last will and testament, This 31st day of December 1888.
