ally my will that my said wife shall
live with my family according to the
following items of this will -

1^o It is my will that my executors shall
keep all of my property together for
the benefit and advantage of my chil-
dren named in the second item of
this Will and my wife and moreover
the same for their reasonable support
maintenance & when any of my said
children shall settle themselves in
life & shall so desire then my execu-
tors shall be authorized if their judg-
ment approve to have the portion that
would fall to them assigned and given
off but as long as my wife and said
named children will remain on my
plantation and at the place I now
occupy then the whole of my effects
to be kept together for their best advantage

2^o It is my will that my son Allen A.
Whitaker Joseph L. Whitaker John S.
Whitaker my son in law Joel Humphrey
shall keep up my business on the place
where I now live so long as my executors
shall determine so to do & that they
each shall have a comfortable support
out of the proceeds of the same not to
amount to extravagance.

3^o It is my will that my executors shall
collect all the money that may be due
to me and all the ready money that
I may leave in hand at my death in con-
nection therewith at interest and to keep
the same so at interest and well secu-
red until the youngest of my said named
children shall arrive at majority or many
then to be divided among my said named
children if they may desire it.
