paid by my Executor herein after named
Item 2nd At & upon the arrival at age of my son
Joshua, I Barbour I desire that my Executor
do pay to him in money the sum of Three
hundred Dollars this to be to him a legacy
additional to his equal share of my Estate
Item 3rd All The rest of my Estate both
real & personal I desire to be kept together
& well used for the support ^{of my} wife

Amurage of Barbour & my Children Joshua of
James W^r & John T Barbour and such other
Child or children as may be by me begotten
by my said wife Annanda of Barbour & until
& until the marriage or death of my said
wife when & at either contingency I desire that
all my Estate both real and personal be
divided between my aforesaid Children share
& share alike

Item 4th If at any time my executors should see proper
to sell my Real Estate or only a part thereof to re-
invest the same in other or like property It is my
desire It is my desire that she do so without being
Compelled to obtain an order so to do from the
Court of Ordinary & that she & that she be
empowered to sell the same at public or
private sale as may to her seem best

Item 5th I hereby nominate and appoint My wife
Annanda of Barbour my Executrix to this my
last will & testament & further when my son
Joshua of Barbour shall arrive at the age of twenty
one It is my desire that he also qualify
as Executor that he may assist & advise his
mother in & about the Management of the aforesaid
Estate In witness whereof I have hereunto set my
hand & seal this December 16th 1863
