Badger for and in consideration of the sum of four thousand dollars to him in hand paid at and before the sealing and delivery of these presents the receipt whereof is hereby acknowledged hath this day granted bargained sold and conveyed and by these presents doth grant bargain sell & convey unto the said Joshua B. Badger his heirs and assigns all that tract or settlement of land lying in the County & State of aforesaid Tennessee & distinguished here as follows to wit lot of land Number Eight in the Sixteenth District of originally Henry now D. Kall & lots number one hundred & twenty nine one hundred & thirty one hundred & fifty nine and one hundred & twenty seven in the fifteenth district of originally Henry now D. Kall County except a portion of the last mentioned lot lying in the South East corner of the same South East of a branch running across the corner of said lot supposed to contain about forty acres formerly owned by George Hall & lately conveyed to David Franklin To have and to hold said lots or parcels of land as above described together with all and singular the rights members and appurtenances thereof to the said Joshua B. Badger his heirs and assigns forever in fee simple And the said Felix H. Badger for himself & his heirs doth warrant & defend the right and title thereof against the claim of himself and his heirs but against the claim of the other person In Witness whereof the said Felix H.
