

State of Georgia This Indenture made and entered into DeKalb County this the first day of January one thousand eight hundred and Thirty Nine between Charles Dinge of the County and State aforesaid of the one part and Rufus Leay of the same place of the other part witnesseth that the Said Charles Dinge for and in consideration of the sum of Two hundred dollars to him in hand paid at and before the sealing and delivery of these presents the receipt whereof is hereby acknowledged hath granted bargained and sold and by these presents doth grant bargain sell alien and convey unto the Said Rufus Leay his heirs and assigns the South half of Lot of Land Number Two hundred and twenty seven in the Eighteenth district of originally Henry County now DeKalb County containing one thousand one and one fourth acres more or less the line dividing said Lot to be run from east to west through the said Lot of Land No 227 and leaving the said South half to the said Rufus Leay to have and to hold the said bargained premises unto the said Rufus Leay his heirs and assigns together with all and singular the rights, members and appurtenances thereto to the same or in any manner belonging to his and their own proper use benefit and behoof forever in fee simple and the said Charles Dinge for himself his heirs Executors Administrators and assigns the said bargained premises unto the said Rufus Leay his heirs Executors Administrators and assigns will warrant and forever defend the right and title thereof against themselves and against the claims of all other persons whatsoever it shall please wheresoever the said Charles Dinge hath hereto to set his hand and seal day and year first above written signed sealed and delivered in presence of us
