bargain and sale by these presents grant bargain and
sell and convey unto Robert H. Smith a lot of land
in originally Henry now DeKalb County Georgia and distinct
guaranteed by lot number fifty in the Seventeenth District
To have and to hold said lot as a base disincumbered so far
as his power as Executor shall extend unto Robert H.
Smith his heirs and assigns together with all & singular
the rights therein to against himself his heirs Executors
and administrators and all other persons or persons what

 together with the all and singular the right members and
 appurtenances thereof and also all the estate right title

 sealing and delivery of these presents the receipt whereof
 is hereby acknowledged the said John Rives has this day
 granted bargained and sold and by these presents do grant
 sell and convey unto the said James Phillips his
 heirs and assigns all that Tract or parcel of Land
 situated lying and being in the sixteenth District of origin-
 ally Henry now DeKalb County Georgia and distinguished
 in the plan of said District by the number sixty six (66) sit-
 ting the south part of said Lot containing one hundred
 and forty acres more or less to have and to hold
 the said bargained premises to him the said James
