and managed by my Executors hereafter
appointed for the support & maintenance
of my wife & my three children
the widowhood of my wife or the

of my children that when my wife comes to
 the eldest of said children becomes of age
 then I desire that all my property both real
 and personal be equally divided between
 my wife & my said children share & share
 alike the part which is given to my wife from
 Law of Power. Secondly I will that my share
 of Hymen Beck be given to my wife &
 that my Medical Books be equally divided
 amongst my children
 I will & constitute & appoint Mr. Ezzard &
 John C. Hill my friends & relatives my Executors
 of this my last Will & Testament hereby revoking
 all other wills by me heretofore made
 & test many others of I have, & would set my
 hand an affixed my seal this 23rd day of January
 1864.
