paid at and before the sealing and delivering of these presents
the receipt whereof is hereby acknowledged hath granted bargain
sold and conveyed and by these presents do grant bargain sell
and convey unto the said Benjamin Little his heirs and
assigns a certain lot of land containing two hundred and
one half acres be the same more or less it lying and
being in the fourteenth district of originally Henry but
now Dekalb County known and distinguished in the plan
of said district by No 20 twenty to have and to hold the said
lot of land together with all and singular the rights
members hereditaments and appertinances thereof
whatsoever belonging thereto to the said Benjamin
Little his heirs executors administrators and assigns
to their only proper use benefit and behoof forever in fee
simple and the said Thomas Oliver his heirs executors
administrators and assigns shall and will warrant and
forever defend right and title thereof against the
claims of themselves and the claims of all and every
other person or persons whomsoever claiming or to claim
the same or any part thereof In Witness whereof
