sold and conveyed and by these presents do grant bargain
sell and convey unto the said Noah R. Reeve his heirs
and assigns all that tract or parcel of land situate
lying and being in the County of original Survey
but now DeKalb County known and distinguished
in the plan of Survey by Lot Number Twenty in
the Seventeenth District of DeKalb County containing
two hundred two & half acres more or less to have and
to hold said tract or parcel of land unto him the said
Noah R. Reeve his heirs and assigns together with all
and singular the right, members, reversion, rents, profits
and appurtenances thereof to the same in any manner
belonging to the said Reeve and their own proper use benefit
and behoof forever in fee simple and the said George W.
