Salt County. This Indenture made this twenty fifth day of June in the year of our Lord One Thousand Eight hundred and forty four between John S. Wilson of said County of the one part and the Georgia Rail Road & Banking Company of the other part Witnessed that the said J. S. Wilson for and in consideration of running this contemplated Rail Road on and along his land as well as in consideration of the sum of one dollar to him in hand paid at and before the sealing & delivery of these presents the receipt whereof is hereby acknowledged hath given granted bargained and sold and by these presents doth give grant bargain and sell unto the said Georgia Rail Road & Banking Company and their successors assigns the right of way over which to pass at all times by themselves Directors officers Agents servants & servants in any manner they may think proper and particularly for the purpose of running erecting and establishing thereon a Rail Road with the requisite number of tracks pursuant to a charter of incorporation passed the twenty first day of December Eighteen hundred & thirty three and amended at subsequent sessions of the General Assembly by conferring Banking privileges and the power of extending the road from Macon to the terminus of the Western & Atlantic Rail Road and to this end the limit of said Right of Way shall extend in width thirty three feet on each side of the center line of the road way of the said Rail Road and shall extend and to extend in length through the tract of land owned and claimed by said John S. Wilson and lying & being in Salt County and being the same of E. B. Butler J. H. Butler & others and shall extend through the
