

Georgia Whereas in obedience to the writ of fier facias issued  
DeKalb County Court of the Superior Court of the County of DeKalb on  
at the suit of John G Roberts Adm'r & the other at the suit of Henry  
Wolf against Frederick Hilsabek and John Brown Deputy Sheriff  
of the County aforesaid did lately seize the fraction of land herein  
described as the property of the said Frederick Hilsabek and after his  
duly and publicly advertised agreeable to law did on the 4th day of  
December in the year Eighteen hundred and Twenty seven at the place  
of public sale in the said County of DeKalb upon the same at public  
 outcry when Thomas Stevens being the highest bidder the same  
was knocked off to him at the price or sum of Forty six dollars  
Now this Indenture made the 4th day of December in the year  
of our Lord one thousand eight hundred and twenty seven  
and in the fifty second year of the Independence of the United  
States of America between the said John Brown Deputy Sheriff  
as aforesaid of the one part and the said Thomas Stevens of the  
other part witnesseth that the said John Brown Deputy Sheriff  
for and in consideration of the sum of Forty six dollars  
to him in hand paid by the said Thomas Stevens at and before the  
Sealing and delivery of these presents the receipt whereof is hereby  
acknowledged hath granted bargained and sold and by these  
presents doth grant bargain and sell so far as the office of  
Deputy Sheriff authorizes him unto the said Thomas Stevens  
his heirs and assigns all that Fraction of land known and  
distinguished in the plan of the Seventeenth district of originally  
County now DeKalb County by the Number (246) two  
hundred and forty one except twenty acres there which has  
been run off of said fraction together with all and singular  
the rights members and appurtenances thereof unto the said  
fraction of land being belonging or in any wise appertaining  
and also the estate right title interest property claim and  
word of the said Frederick Hilsabek in law equity or otherwise  
whatsoever of in or to the same to have and to hold the said  
fraction of land and premises and every part thereof unto the said  
Thomas Stevens his heirs and assigns to the only proper use long  
and behoof of the said Thomas Stevens his heirs and assigns from  
in full and ample a manner as the said  
Frederick Hilsabek or his heirs and assigns did or might  
have held and enjoyed the same had it not been seized and  
sold under the execution aforesaid In witness whereof the
