grants now Dekalb County situated in the State aforesaid
to him and to hold said tract or parcel of land unto the
said William Star his heirs & assigns together with all
and singular the rights, minerals & appurtenances
to the same in any manner belonging to his and their
true proper use benefit and behoof from time past
simple and the said John Rennall for himself

now for and in Consideration of the sum of Five
Dollars by the said Margarett to the said Robert in hand
paid the receipt whereof is hereby acknowledged as well as
for the better securing the payment of the aforesaid prom
issory note the said Robert hath granted bargained and
sold a und stath bargain and sell unto the said Margarett
her heirs and assigns a certain tract of land number
Sixty two in the Sixteenth District originally Henry now
Dekalb Containing one hundred and fifty two and a half
acres to have and to hold said bargain land to the said
Margarett her heirs and assigns to her and their own
benefit and behoof forever and the said Robert for
himself his heirs and assigns and administrators the
bargain land unto the said Margarett will warrant and
defend against himself and his heirs and assigns
against the claim of all other persons whatsoever
provided nevertheless that if the said Robert his heirs
Executors and administrators shall and do or do
not pay or leave to be paid unto the said Margarett
her heirs & assigns the sum or amounts sum of two
hundred & forty dollars on the day and time mentioned
and appointed for the payment whereof in the said
promissory note according to the term of said note
then also from thenceforth as well as his present
term and the right to the land thereunto belonging
as the said promissory note shall then remain
