assigns, all that tract or lot of land, situate being and
lying in the Eleventh District of originally Henry (now DeKalb)
County Georgia and distinguished in the plans of said
district by the number One hundred and fifty five
in said District containing One hundred two and
a half acres, more or less.

And to hold
the said tract or lot of land, with all and sing-
ular the rights thereunto and appurtenances there-
unto to the said tract or lot of land, being belonging or
in any wise appertaining, with the remainders and re-
versions, reversion and reversions unto heirs and assigns
thereof to the only proper use benefit and behoof of
him the said Robert Crockett his heirs assigns ad-
ministrators and assigns in fee simple, and the said
Joseph Crockett Senior his heirs assigns and administrators
do hereby bargain promises unto the said Robert Crockett
his heirs assigns administrators and assigns, against the
said Joseph Crockett Senior his heirs assigns and admin-
istrators and all and every other person or persons, shape
unto with former Warrant and defend by virtue of these
presents.

Robert Crockett for and in consideration of the
sum of Eight Hundred Dollars to him in hand paid
at and before the sealing and delivery of these
premises the receipt whereof is hereby acknowledged
and granted bargained sold aliened and conveyed
and confirmed and by these presents doth grant sell
and convey and confirm unto the said George W. Rivers,
his heirs and assigns One Hundred and fifty two
acres and a half (more or less) of Lot of Land
situate lying and being in the Eighteenth District of
originally conveyed from DeWolf County Thosom and
divided up in the plans of said survey by the No
One Hundred and fifty two in said District leaving
fifty acres of said tract of Land which was divided
to the said Robert Crockett (taking said fifty acres out of
the south east corner of said Lot.)

And the said tract or parcel of Land with all and
singular the rights (Members and appurtenances thereof)
whenever to said tract or parcel of Land, being belonging
or in anywise appertaining with the covenants and con-
ditions, provisions and exceptions unto issues and profits thereof
to him the said George W. Rivers his heirs assigns adm-
inistrators and assigns in fee simple, with the said
Robert Crockett his Executors administrators the said
bargained premises unto the said George Rivers his
heirs assigns administrators and all and every the
