confirmed and by these presents do grant bargain sell alien
Convey and Confirm unto the said Moses W Davis his heirs and
assigns all that lot or tract of land containing five hundred
one and a fourth acres more or less Situate lying and being in the
eighteenth district of originally Henry now DeKalb County known
and distinguished in the plan of said district by being the sou
thwest half of Lot Number one hundred and twenty To have
and to hold the said parcel of land with all and singular
