Dekalb County 3 January in the year of our Lord one thousand
eight hundred and forty three between William Fair of the
County of Douglas the one part and Joseph Pitts of the County
of Dekalb of the other part witnesseth that the said William
Fair for and in consideration of the sum of one hundred
dollars in hand paid at and before the sealing and delivery
of these presents the receipt whereof is hereby acknowledged
hath granted bargained sold alined conveyed and confirmed to
the said Joseph Pitts his heirs and assigns all that tract
or parcel of land situate lying and being in the fifteenth
district originally known now Dekalb known & distinguished
now in the plan of Survey as lot Number two hundred and
thirty nine (39) being one undivided half of said lot
containing one hundred one and one fourth acres more or less
To have and to hold the said premises with all and singular the
rights franchises privileges and appurtenances thereunto relation
to the said premises belonging or in any wise appertaining with
the remainder and remainder reserved and reserving unto
him and profits thereof to the only proper use benefit and
service of the said Joseph Pitts his heirs Executors Administrators
and assigns in fee simple over the said William Fair
his heirs Executors and Administrators as warrant and will
form defend the premises hereby conveyed unto the said
Joseph Pitts his heirs Executors Administrators and assigns
against the lawful claim of the said William Fair his
heirs Executors and Administrators and of all other persons
whatsoever. In witness whereof the said William Fair

and John B. Glavin of the same place of the other part.
Witnessing that the said Nathaniel Morgan for and
in consideration of the sum of two hundred dollars

obliges to him or his heirs and assigns all that
debt or charge of these presents the receipt whereof is hereby
acknowledged hath granted bargained & sold & conveyed unto the
said John B. Smith his heirs and assigns all that
tract or parcel of land situate lying & being in the
Courtinthe District of Oconee County but now Dalt
County known & distinguished by number one hundred
& forty two (162) To have & to hold the said tract or parcel of
land unto him the said John B. Smith his heirs and assigns
together with all & singular the rights & appur-
tenances thereto to the same in any manner belonging
to his & their own proper use benefit & behoef from
in fee simple and the said Nathaniel Mangum
for himself his heirs executors & administrators shall
bargained promises unto the said John B. Smith his
heirs and assigns will warrant & forever defend the right
title thereof against themselves & against the claim

of the sum of Two hundred dollars to him in hand
paid at and before the delivery of these presents the sum
whereof is hereby acknowledged hath granted bargained &
conveyed and confirmed by these presents unto the said Mangum
all convey and confirm unto the said James Mangum
his heirs and assigns all that tract or lot of land there
lying and being in the Courtinthe District of Oconee
County but now Dalt County known & distinguished as
the plat by No 162 one hundred and forty two containing
213½ acres hundred two and a half acres more or less

To have and to hold the said bargained premises with all
and singular the rights & appurtenances thereto and appertaining
thereof whatever to the said premises belonging or in any
manner relating thereto in fee simple and profits therefrom to the said
use benefit and behoef of him the said James Mangum
his heirs executors administrators and assigns
and the said John B. Smith for himself his
executors and administrators et al and his
successors & assigns forever
