bearing even date with these presents whereby the said
James Ball hath promised to pay the said Peter Ball
or bearer the sum of One hundred and fifty three Dollars
on or before the first day of March Eighteen hundred and
forty five with interest from the twenty fifth day of August
last for value received Now for and in Consideration
of the sum of six Dollars by the said Peter Ball to the said
James Ball in hand paid the receipt whereof is hereby acknowledged
as well as for the better securing the payment of the aforesaid
promissory notes the said James Ball hath granted bargained
sold and doth by these presents grant bargain and sell unto
the said Peter Ball his heirs and assigns all three tracts
