Madison and the aforesaid state of the other part witnesseth
that the said Thomas Thrower for and in consideration of the
sum of Fifty dollars to him in hand paid by the said William
L. Connally at and before the sealing and delivery of these presents
the receipt whereof is hereby acknowledged hath granted bargained
sold and released and confirmed and by these presents doth
grant bargain sell release and confirm unto the said
William L. Connally his heirs and assigns forever all that
tract or parcel of land situate lying and being in the fourteenth
district originally Henry now DeKalb County containing Two
hundred Six and a half acres more or less known and distinguished
by number One hundred and Seventy eight to have and to
hold the said tract of land with all the rights and appurtenan-
ces unto the said William L. Connally his heirs and assigns
forever and the said Thomas Thrower for himself his heirs

proper use benefit & behoof forever in full simple to take
