Malton County 3rd ember in the year of our Lord one thousand
eight hundred and forty two between William Armistead of
the county and state of Georgia of the one part and George
Malcom of the same place Witneseth that the said William
Armistead hath this day made and delivered to the said
George Malcom his certain promissory note subscribed
with his hand and bearing even date with these presents
whereby the said William Armistead hath promised to
pay the said George Malcom or bearer one hundred
and ninety five dollars $4\frac{1}{2}$ cts on or before the twenty
fifth of December Eighteen hundred and forty three for value
received now for and in consideration of the sum of
five dollars by the said George Malcom to the said
William Armistead in hand paid the receipt whereof is
hereby acknowledged as well as for the better securing the
payment of the for said promissory note the said William
Armistead hath granted bargain and sold and doth by
these presents grant bargain and sell unto the said George
Malcom his heirs and assigns all that tract or lot of land
situate lying and being in the fourteenth district of formerly
Newly Now De Kalb County known and distinguished in
the plan of said district by the number eighteen contain-
ing two hundred two and a half acres to have and to hold
said bargain premises to the said George Malcom heirs and
assigns to his and their own proper use benefit and behoof
forever and the said William Armistead for himself his heirs
executors and administrators the said bargained premises
unto the said George Malcom will warrant and forever
defend against the claim of himself and his heirs and assigns
the claim of himself and his heirs all other persons what-
ever provided nevertheless that the said William Armistead
his heirs executors and administrators shall and do
well truly pay or cause to be paid unto the said George
Malcom his heirs and assigns the aforementioned sum of
one hundred and ninety five dollars and $4\frac{1}{2}$ cts on the
day and time mentioned and appointed for the pay-
ment thereof in the said promissory note mentioned
with lawful interest for the same according to the
tenor of said note then and from then forth as
well this present indenture and the right of the prop-
erty thereby conveyed as the said promissory note shall
hereafter determine and be void to all intents and

assigns all that tract or parcel of land situate lying and
being in the fourteenth district of originally Henry now
DeKalb County known and distinguished in plan of said
District by the number ninety five containing one hun-
dred one and a fourth acres more or less it being the north
half of the above named lot adjoining John Lee and others
with all the rights members and appurtenances thereto
belonging to have & to hold the afore described parcel of
land unto him the said S S Caine his heirs and assigns
together with all the rights members and appurtenances to
the said parcel of land in anywise belonging to him and
their proper use benefit and behoof forever in fee simple
and the said Thomas Mcendon for himself his heirs executors
and administrators the said bargained premises together
with the right title and possession thereof unto the said
S S Caine his heirs and assigns will warrant and forever
defend the right and title thereof against themselves and against
