of advanced age but of sound and disposing mind and memory do make this my last will and testament of which all other Testamentary devices of any shape heretofore made by me are revoked

Item 1st It is my will and direction after my death with decent burial suitable to my ~~circumstances~~ and condition in life and the payment of all just debt and expenses necessarily incurred in the management of my estate shall all have been paid the balance of my estate both real and personal shall descend to and belong to the persons named in next item of this my will

Second it is my direction will and request that all land which consists of the place where I now live the Ferry with Landings on both sides of the Chatahoochee River at Camptown with all land attached to the same the chain Ferry Boat with all my stock of Cattle Horses Hogs and all stock of any sort I may own with house hold and kitchen furniture plantation tools and all debts due to me ready money after the payment as expressed in the first item of this my will shall be whatever remains the property of Betsey Bomer my daughter Widow of Elsha Bomer and my daughter Melvina Parker Wife of John A. Parker and my Executor him or named shall divide the same equally between them and the sum is to be their property and in case of the death of one or both of my said daughters

before such division then children is to
stand in place and stead of such deceased
one I have no preference of my children and
the reason I direct for nothing to go to Mary
Whitty my daughter wife of Evan R. Whitty
is that I consider and know it to be true
that she has through said Evan R. Whitty
got more of my estate in the way and
manner generally known that I have given
to the other two of my children
Which I have constituted and apoint my
son in Law John A. Barker, my two grand
sons ~~Armistead~~ R. Bomer and Barker R. Bomer
to act as Executors in carrying out this this
my last will and testament who are
to act in the way and manner mentioned
herein. It is my direction after proof
of my will and granting Letus Leland
that have an inventory and appraisement
of all my estate then they are to make
but one return to the Court of Ordning
which is to be a final return and in
making division as directed if necessary
to make sales my executors are fully empowered
to make sales in any way for the best
interest of the said daughters without
asking leave or other expence from the
Court of Ordning.
