Item 1) I give to my beloved wife Eliza F. Jones my house
situated in the Village of Bluffton Wm County, Ga. consist-
ing of thirty one acres also my Dressing Room
hall and kitchen furnished as herein after Enu-
merated I also give her an equal portion in the balance
of my Estate

2nd, I desire all the balance of my Estate to be equal-
ly divided between my wife Mary Christian Jones and
that portion which would be coming to me I
I F. Jones I will give his portion to his children
his children that are now living or may be
born here after

3rd I give unto my Daughter Fannie Jones
a mortgage due which I have over a portion
of a Lot of Land lying in East County Ga. to wit
not remembered adjoining lands of J. P.
McMillan and W. F. Roberts and others

4th I give unto my Daughter Emma

5th It is my Will that James F. Jones and
the children of John F. Jones should have
my Estate for the sum of five hundred dol-
lars for advancements there to give made to
said James F. Jones and John F. Jones and
not to account for more than that sum

6th To such of my children as have not
had a bed and furniture given them here before
I desire them to be furnished with the same out of
the furniture which I am disposed of at my death

7th In as much as by a Marriage Contract
entered in to by myself and wife previous to
our marriage all of the personalty and Real
Estate belonging to her at that time or that she
might afterwards inherit or acquire was
secured to her as her individual property and
in as much as she has other children by a
former husband I deem it right but right
that the portion in this will set apart to
her should rest in her only a life Estate
and at her death to belong to our little daughter

Gisa and so I will. And I hereby appoint my Son in Law F. Rambo, as guardians of the property of my Daughter Gisa

I hereby appoint my Son Thomas G. Jones my Sole Executor with special power to take Charge of and Control of all my Estate and manage and Control it in the full same as complete as a manager or Executor of living and to keep same free from all encumbrances till time for the payment of my debts for the purpose of supporting and educating my said Children and the education of the same. I hereby authorize my Executor to sell or dispose of all or any of my lands and tenements in Georgia and any compensation for same not to exceed the sum of five hundred dollars and to pay the same to my Children

9th. I desire my wife die before my Child Gisa becomes of age. I desire my Daughter Mary Rambo to have the Charge of her and receive her education
