delay by my Executors herein after appointed.

3rd I give bequeath and devise to my beloved wife Nancy
Wester one Hundred acres more or less of lot of land
number forty three (43) and all the land on lot number
four (4) situated and lying South of the big branch
containing three Hundred and fifty acres more or less in
the Sixteenth District of said County with all the rights

wise belonging forever in fee simple in Law of
Dower I also give and bequeath to my beloved wife
Nancy Wester in the same unreserved manner all of my
farming and Mechanical tools used on or belong to the
farm all of my Stock of Mules Horses Hogs Sheep
goats and Cattle and all of my Household and

Kitching furniture all of which personal property to
remain for the use of my beloved wife so long as
she may live or remain a widow and after her death
or intermarriage I direct that it be equally divided

between my two sons Daniel B Wester and Henry
Wester Jr and my Daughter Nancy B Wester share and
share alike the land or real estate given bequeath
and devised to my wife Nancy Wester in Law of
Dower I direct after her death or intermarriage

equally divided according to value between my
two sons Daniel B Wester and Henry L Wester Jr

4th I give bequeath and devise to my two sons Richard
J Wester and Matthew M Wester all that part of lot of
land number three (3) and four (4) in the Sixteenth
District of said County situated lying North

of the big branch containing seven hundred acres
more or less with all the rights members and
appurtenances thereon belonging former in
fee simple

5th I give and bequeath to my Daughter Zilpha
Simson wife of Daniel Simson for her sole
and separate use during her natural life subject
to the debts of her present or any future
husband the following property to-wit Eight
(8) Cows and Calves for her own proper use
during life and then to her children

I having heretofore deeded to her Eleven hundred
acres (1100) of land and two Cows and Calves
after her intermarriage with said Daniel
Simson the same being the full amount of
property I did and direct that she shall receive
out of my estate

6th I give and bequeath to my Daughter Mary

Wester for her sole and beneficial use
of land more or less with all the rights members and
appurtenances thereon belonging former in
fee simple

7th I hereby constitute and appoint my friend
Humphrey Allen executor and Mary Wester
my sole executrix of my last will and
testament this I do in the 2nd year signed
A. L. Wester (decd) signed sealed and
published in our presence and in the
presence of each other this I do in witness
