Jeffery, Cloe and three Children, Sue, prinu

and Rose, one boy pompoy and their Issue to be Equally
Divided Between them Share and Share a like and
to ~~them~~ be their property for Ever, in Consideration of
which I have hereunto these presents Interchangeably
Set my hand and Seal this Eight Day of April In the
year of our Lord one thousand Seven Hundred & Eighty
