Georgia ³ In the Name of God Amen
 Elbert County ³ I Slice Nelsons of Said State and County

 Memory do make and publish this my last Will and
 Testament

- 1st I direct and desire that my body be buried in a decent
 and Christian like manner suitable to my Circumstances
 and Condition in life My soul I trust will return
 to God Who gave it
- 2^d I direct and desire that all of my just debts be paid by my
 Executor herein after to be appointed
- 3^d I give and bequeath at and after my death to my son
Nathaniel H Nelson, my Daughter Elizor J Nelson and my
 Daughter Martha H Nelson my tract of land wherein I

Now live in Said Elbert County Georgia Wills 1838 to 1860th hundred and seven
acres more or less adjoining lands of Mrs A' Hendrie &
Abner H' Ginn and others also all my stock of every description and
all my Household and Kitchen Furniture and all of my plantation
Tools after my just debts is paid to be equally divided between
the three above named Children

4th I hereby constitute and appoint James D' Duncan Executor
of this my last Will and Testament this January 22nd 1859
