Angus McCurry's Will 1840.

In the name of God Amen -

I Angus McCurry senr. of Elbert County Georgia. being weak in body, but of sound mind & memory reflecting that death is the certain lot of all men & believing in the Christian religion & in a general resurrection I recommend my soul to God who gave it and my body to be buried in Christian decency at the discretion of my Executors -

secondly. I will & bequeath to my beloved daughter Margaret McDonald fifty Dollars & the sum of ten dollars to each of her children herein named, viz. Nancy, Margaret, & Rodrick, and in like manner ten dollars to each of the children of my beloved daughter Sarah Gordon herein named, viz. Mary, Flora, Eleanor, Angus, John, Robert & Margaret & to her son Thomas five Dollars -

thirdly. I will & direct that after the compliance with my second item all the monies arising from the sale of my property, or the money due me be divided into three equal parts, one of which parts to be given to my beloved daughter Margaret McDonald, and one other equal part to be given to my beloved daughter Sarah Gordon, and the other equal part to be disposed of in the manner following, viz.

The one half of ^{Elbert County, Georgia Wills 1836 to 1866} ~~the~~ divided equally between my Grand daughter Flora Juy & Margaret McCurry and the other half of the aforesaid Equal part to be divided among my great grand children the children of Daniel L. McCurry ^{www.georgiapioneers.com} died at their becoming of age, but if none of said great grand children should live to age in that case the portion I allot to them shall return to & be equally divided between my two daughters Margaret M. Donald and Sarah Gordon. and further I give unto my beloved daughter Margaret M. Donald my bed & bed furniture, and to my beloved daughter Sarah Gordon I give my Kitchen furniture

Fourthly. I will that my four negroes be sold to the highest bidder on a credit of twelve months together with my lot of land, my stock of cattle & any articles of property of which I have not otherwise disposed of & the proceeds of said sale together with the money due me be disposed of as directed in my third Item -

Fifthly. I appoint & ordain John Gordon & John McDonald my Executors to this my last will & Testament. Revoking & entirely disannulling all wills & Testaments by me heretofore made

In Witness and in Testimony whereof I have hereunto set my hand & affixed my seal this sixteenth day of June in the year of our Lord eighteen hundred & thirty six
