- Georgia } In the name of God Amen,
Elbert County } I Daniel Bond of the County and State
aforesaid being of Sound and disposing mind and Memory
do make and publish this my last Will and Testament
revoeking all Others heretofore made and Firstly I
Commit my Soul to God Who gave it
- Item 1st I Will and desire that my Just Debts be paid
as soon as it can ~~be~~ conveniently be done
- Item 2nd I Will and desire that my property both real and
personal be sold by my Executors in the manner they
shall think most advantageous to my Estate
- Item 3rd I Will and desire that my property after being
Turned in to Money as above shall be Equally
divided Share and Share a like between all my
Children to wit Edy C Sanders wife of James
M Sanders James W Bond Jane E Bond Susan C
Bond Eppy M Bond Nelson C Bond Mary A
Bond Martha E Bond Thomas M Bond and Sarah
P Bond and is to them to be Share and Share a like
with the Exception of my Daughter Susan C Bond
and I Will and bequeath to her One hundred dollars
Over and above an Equal Share with the other Children
- Item 4th I Will that the Share I have above given to my
Daughter Edy C Sanders Wife of James M Sanders
is to her and Childrens own Separate use and benefit
and is to them for ever free from the Control of said
Husband and is to her and her Children born or to be
born own Separate use and I here by appoint my
Executors the Trustees for my said Daughter and her
Children
- Item 5th I Will and desire that Should any of my above
Named Children die with out heirs of there body then
and in that case I Will that the amount they shall
inherit of my Estate shall revert back to my Estate and
be Equally divided Share and Share a like between
my remaining Children or Grand Children Should I
have Grand Children at the time whose parents were dead
I Nominate and appoint my Sons James W Bond and Eppy
M Bond my Executors of this my last Will and Testament
