Henry White's Will 1842

In the name of God Amen, I Henry White of the State and
Elbert County } County aforesaid knowing the surety of death and uncertainty
of life, and being of feeble health but of sound and disposing
mind have thought it advisable to make disposition of the worldly effects
with which it has pleased kind heaven to bless me in a Temporal point of
view do ordain the following to be my last will and Testament and
hereby declare it to be so.

Item 1st It is my will that I be decently buried and that my funeral
expenses be paid -

Item 2nd It is my will that all my just debts be paid.

Item 3rd It is my will that should my wife Mrs. White be living at the

is to have the property of my personal life at her death to be divided in the following manner Between my son Thomas S. White and my William B. White my daughter's Eliza Frances Dean, Sarah Ann Virginia Freeman & Lucy Jane Victoria Merrimether. To my son Thomas S. White, I give and bequeath my negro man Chiser and to my son William B. White I give and bequeath my negro man Jordan which said Two sons are to receive half of the balance of my estate by the value of the said negroes to wit Chiser & Jordan

Item 4th I Give and bequeath to my five Children Thomas S. White, William B. White Eliza Frances Dean, Sarah Ann Virginia Freeman & Lucy Jane Victoria Merrimether the balance of my negroes to be divided in such a way as that my three Daughters above named shall have more than my two sons Thomas & William by the value of the said Two Negroes Chiser & Jordan which were disposed of in my third Item.

Item 5th Should my wife Mary S. White feel disposed to give off any of my said Negroes my executors hereafter named shall cause the said negroes so to given off to be appraised by competent appraisers and all such gifts or legacies must be made in accordance with said appraisements.

Item 6th It is my wish and desire that my perishable property be sold and the proceeds of said sale divided equally among my five children as above named at the death of my wife Mary S. White

Item 7th It is my will that it should be left with my executors to make such a disposition of my landed estate as they may think advisable.

Item 8th Should I be possessed of any money and evidences of Debt it is my will that the said money and evidences of debt be divided between my five children above named equally.

Item 9th For the purpose of of conveying out the provisions contained in this my said will I do hereby constitute and appoint my sons Thomas S. White & William B. White and my son in law Samuel Freeman my executors

Nancy M. Hunt's Will 1842

State of Georgia } In the name of God Amen, I Nancy M. Hunt of
Elbert County } the County and State aforesaid being of sound
mind and memory and knowing that it is appointed

for all once to die, do make and ordain this my last will
and Testament in manner and form following, to wit:

First I commend my soul to God who gave it and entreat him in
mercy to receive it through the mediation of Jesus Christ who once offered
himself up a sacrifice for sinners and my body I command to the
Earth to be buried in such manner as my Executors whom I shall
hereafter appoint may think proper not doubting but in the general
Resurrection of the dead I shall receive the same again by the
mighty power of God. And as touching such worldly goods or
estate as it hath pleased God to bless me with in this life, I order and
dispose of in the following manner.

Item First, I desire that all my just Debts be paid.

Item second I will and desire that the whole of my Real estate be
sold by my Executors as the Law directs in such parcels or
quantities and on such time as to them shall seem best, and
that the proceeds thereof be equally divided between my
two Children James Hunt, Sally Harris and the heirs of my
son Elijah Hunt.

Item third, I will and desire that the whole of my Personal
Property or Estate of whatever name nature or quality,
be annexed to and considered as a part of the personal
estate now in my possession by virtue of the will of my
beloved Husband Richardson Hunt in so far as that it shall
be equally divided at the same time & place of the personal estate
enjoyed in said will between my children James Hunt, Sally
Harris and the heirs of my son Elijah Hunt to them and their heirs.
