I John H. Gray of the County of Winston and State of Mississippi being of Sound mind Memory and understanding do make and publish this my last Will and Testament hereby revoking and making Void all former Wills by me at any time heretofore made First I Give devise and bequeath to my Wife Mildred W. Gray all and singular that property and Estate real and personal to gether with the Increase thereof which belonged to her and of which she was possessed at the time of our Marriage the said

Estate being and hereby devised and bequeathed being a certain plantation situated on Beaver dam Creek Near the Savannah River in Elbert County in the State of Georgia to gether with all and singular the negro Slaves and their increase and the Stock and ~~the~~ other property and effects to the said plantation appertaining and belonging and I hereby will and declare that the devise and bequeath hereby and herein made as aforesaid to my said wife Mildred W. Gray are by me meant and intended to be in lieu bar and satisfaction of all and every Claim and demand of Debtor or other Claims and demand whatsoever on my Estate real or personal which she could or by law might have at the time of my decease of in or to my said Estate real or personal or any part thereof

Second I give devise and bequeath unto my son William Henry Gray and my Daughter Nancy Elvira Hudson Narcissa Eliza Potts and Martha S. Hudson all and singular my other real and personal Estate and effects whatsoever and where so ever of which I am now possessed and to what which I may have any right Claim or demand at law or in Equity at the time of my decease to be divided Equally between and amongst my said son and Daughters share and share alike

lastly I do hereby Make Nominate and appoint My son William Henry Gray and My Son in law Robert S. Hudson Executors of this my last Will and Testament in Witness whereof I the said John H. Gray have to this my last Will and Testament set my hand and seal this the thirteenth

day of September in the year of our Lord one thousand eight hundred and fifty



I John H Gray of the County of Winston and State of Mississippi do make and publish the following Codicil to my Will in manner and form following that is to say
Whereas I have in the second item of my Will devised the residue of my Estate real and personal to be Equally divided between all my Children Now it is my Will and desire that if any of my Children should die without any legal Male descendants there it is herein provided that the property to which they may be entitled under the said second item of my Will shall go to and distribute amongst my then surviving Children share and share alike and it is further my Will and desire if any of my Children should die leaving issue then that such issue or descendants shall take the parts of my Estate their Father or Mother as the case may be would have taken had he or she survived it is further my Will that if the Executors named in the last item of my Will should die before the Execution thereof and in that case I appoint my Senior Law Dr H. S. Potts & Edward M. Tilden my Executors of Talladega County Alabama of this my last Will and Testament in Witness Whereof I have hereunto set my hand and seal to this my Codicil written with my own hand

& held for valid and effectual as much as if proven

as his last Will and Testament that he did so at the
date thereof that he was then of sound mind and
disposing Mind & Memory that he did so without Fraud
or undue influence and that it is Truly his last Will
& Testament and should be so held declared and
recognized and we desire & pray the Probate Court of Winston
County to Establish the Same June 15th 1858
