In the name of God Amen I Benjamin Baker of the County of Franklin & State of Georgia being sick & weak in body but of sound mind & memory & understanding praised be God for it) & considering the certainty of Death & the uncertainty of the time thereof & to the end I may be better prepared to leave this world when ever it shall please God to call me hence do make & declare this my last will & Testament in manner following (that is to say)
First & principally I recommend my soul unto the hands of Almighty my Creator hoping for free Pardon & Remission of all my sins & to enjoy everlasting happiness in his heavenly Kingdom through Jesus Christ my Saviour My Body to the earth at the discretion of my Executors after named

I do hereby give & bequeath to my wife Comfort Baker during
her natural life the place whereon I now live with all my
personal Estate Except Two Feather Beds & furniture &
her Death the whole of the same which may be left
give & bequeath to my son Benjamin

Secondly I give & bequeath to my son John Baker
hundred & forty acres of Land lying & being on Little
Kerrett known & called the Poultry tract

I leave the Elbert tract of Land to pay my Debts

Thirdly I give & bequeath to my Daughter Jane Baker
one Feather Bed & furniture to be delivered to her by my
Executors at her intermarriage or sooner if the said
the Decedent, advisable

Fourthly I give & bequeath to my Daughter Onon Baker
one Feather Bed & furniture to be delivered to her by my
Executors at her intermarriage or sooner if the same
be deemed advisable

Fifthly & as I have heretofore given to my other Children
their Equal Portion of my Estate I do hereby give
them in their Claim & Gift as aforesaid

Sixthly & lastly I do hereby ordain & constitute
appoint my son Christopher Baker & Frost Bell
whole & sole Executors of this my Last Will & Testament
