 Daughter of Archibald and Elizabeth his wife
 my own daughter Chila part of the plantation
 whereon I now live being that part whereon I
 now live during their State of the Celibacy of them
 that is now single and do now live with me
 together with Mayan H Jordan until she becomes
 twelve years of age that to be sold to the highest
 bidder at twelve months credit note and approved
 Securit and the proceeds of the Land to be equally
 divided among all my Sons and the Land which
 Lion White do own and improve it is my will
 that it be rented out until the said Mayan Jordan
 becomes of the age of twelve years and the pro-
 ceeds of it to be equally divided amongst my children
 that is now married to wit my Son Smith Lion
 White Jerusha Chandler Benjamin H White
 and it is my will that if any one of them
 should marry before that this Chila becomes of
 the age of twelve years that they loose their
 right of living on the present occupied prem-
 ises and take their part with the married chil-
 dren now specified in this my last will and
 testament and also it is my will that a
 Certain bay horse about 6 year old be sold
 to the highest bidder on twelve months
 credit from my decease with note and
 approved Securit to pay my debts now standing

my heirs that if he fails to
 the same they will pay balance as dutiful children
 should do they will pay as to my body I leave to
 disposal of my heirs and Executors to bury me in
 decent manner nothing doubting that Christ will
 Raise me with his Sould in the morning of the
 morning of Resurrection and this I make and
 ordain my last will and testament and I
 appoint and Ordain Martin White and Henry
 my Lawful Executors and do now order them to
 Archibald Jordan two dollars and fifty Cents together
 with what I have already given him and this
 all he shall ever have as my heir and this is my
 my last will and testament Revoking all other
 wills and testaments heretofore by me made.
