I Am a Mason widower of the City of St. Augustine
 County of St. Johns in the State of Florida being of sound
 mind and disposing in view of the uncertainty of life do
 hereby make publish & declare this my last will & Testament
 revoking and making null and void all former wills made
 by me at any time The worldly estate with which I am in his
 good luck has been pleased to intrust me I give & dispose of as
 follows

Item first I direct on my decease my body to decently &
 suitably interred in such place & manner as my dear Angeline
 may direct & that all my funeral expenses & debts be
 paid from any part of my estate as soon after my decease as my
 Ex. cutances can conveniently do so

Item Second

I give devise & bequeath to my dear daughter
 Maria & Catharine and Mahinda W. Mason all my property
 and estate real & personal of every nature & kind & wherever the
 same may be situated including all my Negroes in the State
 of Florida & all claims of which I may be possessed seized
 or own at the time of my death to be equally divided between
 them share & share alike as herein often directed

Item Third

Item Third

It is my will & hereby direct & ordain that the
 property & estate herein given devised & bequeathed to my

Constituted by the probate court or judge of Probate
or other Court a trustee or trustees in the place of the one so deceased
designated or disqualified the said Maria to name & select the person
to be appointed her trustee or trustees. That she to name & select the
person or persons to be appointed her trustee or trustees. This however
my desire & so ordain that no future husband of either of my dear
daughters be appointed a trustee for the daughter to whom his is
married.

Item Seventh, I hereby further direct and ordain that my dear
daughters Maria be constituted by the Trustee in the management
sale and investment of the share and moiety of my property
and estate herein given devised & bequeathed to her
and that my dear daughter Matilda be constituted by
the trustee in the management sale & investment of the share
& moiety of my property and estate herein given devised
& bequeathed to her and that investment of the property
held in trust for each of my dear daughters be made for them
with their approbation each approving the current month made
for her.

Item Eighth I hereby give power to my Executors herein
after named to them jointly selling as each act as
such & to the other acting separately should one die or come to
act full power and authority to bargain sell grant & convey by
perfect title, even with full covenants & warranty when
proper any and all the property estate real & personal of
which I shall be seized possessed or the owner without any ap-
plication to or any order from any judge or justice or any
Court of probate or Court of any kind to execute and
accomplish the deeds or bills to sell the same concerning the
whole interest & property therein in fee simple in law as I could
do if living until I should have other joint & to invest the
proceeds of any such sale must be made in a manner
as to my said Executors they shall think most proper
of my estate in such sale or investment by my Executors
I direct them to divide the said my dear daughter Matilda
