 eighty five, and Harriette one hundred, Priscilla fifty five
 dollars, and my son James H. Wright fifty dollars and
 after all debts is paid the remainder to be divided equally
 and that my son Harriette is to have the benefit of his
 share in the Loan Association

 as my executor of this my last will August 10th 1861

State of Georgia - I Joseph Hays Mead being of sound disposing
Hulton County mind and memory much advanced in life do
make this my last will and testament revoking all others
Item 1st It is my will and desire that my ^{only} daughter Mead take all
my estate both real and personal of what kind soever and that
she pay all lawfull and just debts and claims that may be against
me and that she enjoy the property I leave as she pleases and at her
death to distribute among our children as she may think best and
according to her pleasure

Item 2nd I do not wish my wife to be at any expense in an ex-
ecution and therefore it is my will that she take all my property
and manage it as she likes either to keep and divide it among
our children or sell it and convey title and use the funds as
she pleases

I appoint my wife as the proper person to fulfill this my wish
