Secondly my will is and I do appoint my beloved son
Robert Kincaid and my good friend William Mangum my
Sole Executors and ordain them to attend to the my
Last will and Testament and that they put off with
my Deceased have my body buried in a decent and Christian
like manner secondly that they have all my Last & fully
settled off thirdly my request is that they Council advise
and assist my beloved wife in the management of
her living through life also my will is that should she
be any thing less after the decease of my beloved wife
and Daughter Elizabeth as aforesaid the remainder
divided amongst the said six in the following manner
and to wit my will is that Ezekiel Sanderson have
one dollar and Solomon Lookout have five dollars
and that the ring of my eldest son James Kincaid
deceased have two dollars and that the remainder
be divided into five shares as followeth William Kincaid
one fifth John Kincaid one fifth Robert Kincaid
one fifth Robert Conly one fifth and that the
other fifth be equally divided and that William
Lugin have one of the halves & that John & Eby
& standing have the other halves &c
