 that I must shortly depart this life deem it right
 and proper both as respects my family and myself
 that I should make a disposition of the property
 which a kind providence has blessed me I do therefore
 make this my last Will and Testament hereby
 revoking and annulling all others by me heretofore
 made

First. I desire and direct that my body be buried
 in a decent and Christian like manner suitable to
 my condition and circumstances in life My Soul I
 trust shall return to rest with God who gave it
 as I hope for salvation through the merits and
 atonement of the Blessed Lord and Saviour Jesus
 Christ.

Second. I desire that all my just debts be
 paid without delay by my executors hereinafter
 named & appointed.

Third. I give and bequeath to my beloved Wife
 Louisa Borders all the money that I may have
 on hand at the time of my death and also
 all the notes accounts and demands that may be
 due at that time and also all my stock
 including Horses Cattle and Hogs and Farming Tools
 of every kind together with one one horse wagon
 and open top buggy the property mentioned in
 this item of this my Will I desire that the
 same shall belong absolutely to my said Wife or
 a sufficiency of it to supply her wants and
 necessities and out which she shall have a
 comfortable support and maintenance.

Fourth. I also give and bequeath to my beloved Wife
 all my household and Kitchen furniture.

Fifth. I also give and bequeath to my beloved
 Wife for and during her natural life one
 hundred and fifty eight acres (158) of Lot of
 Land number one hundred & forty and fifty
 acres of Lot of Land number one hundred and
 forty nine in the 7th District and 3rd section
 Gordon County containing in all 208 acres
 In event however the property will be

said wife in item third and fourth of this my Will should not be sufficient for an ample and competent support for my said wife then and in that event my said wife is hereby empowered to sell so much of the real estate mentioned in item fifth of this my Will as may be necessary to provide for her a competent and sufficient support during her natural life.

Sixth I desire and direct that my executors hereinafter appointed shall faithfully and diligently collect all the notes due and demands that may be due me at the time of my death and the money when collected to be used for a decent support of my wife as directed above.

Seventh Should there remain on hand, at the death of my said wife any personal or real property not used by her for her support and maintenance during her life time I direct my executors to sell said real and personal property at public outcry to the highest bidder giving usual notice of said sale and that said executors sell on nine months time taking notes with approved security from purchasers.

Eighth After the death of my said wife I direct that whatever money there shall be left remaining on hand shall be disposed of as follows to wit I will and desire the same shall be equally divided among all my children except Ellijay Hooper my daughter, I desire to have three hundred dollars less than any of the rest of my children on account of advances heretofore made to my said daughter. My Will and desire is that the funds going to Rebecca Holden and Ellijay Hooper on selection by them of real estate that my executor shall invest the money owing to said daughters in such real estate and the title to be taken to said Rebecca Holden and Ellijay Hooper severally and the heirs of the body of each of them begotten to be absolutely free from the debts and liabilities of their husbands and in investment by

said executor coming to my said Daughters as above directed said executor not to be held liable further for said money.

Ninth I direct that my Executors erect a brick wall around family grave yard three feet high & wooden frame three feet high and covered with slate.

Tenth I hereby constitute and appoint my Wife Louisa Borders and my Son Edmund Borders Executors of this my last Will & Testament.

Eleventh The necessity to make Annual returns on the part of my said Executors is dispensed with Signed sealed and published by Andrew M. Borders as his last Will and Testament in the presence of the undersigned who subscribed our names herunto in the presence of said Testator at his special instance and request and in the presence of each other.
