Last Will of James A. Cantrell

State of Georgia Gordon County

In the name of God - Amen. I James A. Cantrell of said State and County being of sound and disposing mind and memory, knowing that I must depart this life deem it right and proper both as respects myself and family that I should make a disposition of the property with which a kind Providence has blessed me. I do therefore make this my last Will and Testament hereby revoking and annulling all others by me heretofore made

First - I desire and direct that my body be buried in a decent and Christian like manner suitable to my circumstances and condition in life. My Soul I trust shall return to rest with God who gave it as I hope for salvation through the merits and atonement of our blessed Lord and Saviour Jesus Christ

Secondly - I desire and direct that all of my just debts be paid without delay by my Executors herein after named and appointed

Thirdly - I give bequeath and devise to my beloved wife Mary V. my Daughter Sallie E. my son Walter & my Daughter Mary all of my Estate both Real and Personal after the payment of my just debts share and share alike the same to be controlled by my wife Mary V. during her lifetime by and with the Council and Consent of my Executors as they may think best for the support and maintenance of my said Heirs & should my said wife depart this life before the youngest child becomes of age then dispose of as they may think best divide the same Equally between my three living children or should any of the Children be dead leaving Heirs living Heirs then they to receive the portions that the Parents would have received were they in life

Fourthly - I constitute and appoint my Friends Samuel C. Cantrell & Festus A. Cantrell Executors of this my last will and Testament. This July 13th 1880

I Ann Atherton of Gordon County make this my last will. I give devise and bequeath my estate and property real and personal as follows that is to say To Daniel Norwood the whole of my estate as follows Eighty (80) acres of lot of Land being the west half of Number (263) situated in the (6th) District and 3rd section of Originally Cherokee now Gordon County. all my household and kitchen furniture with my wearing apparel except such as James Atherton may require for his own use all my stock consisting of one horse two Cows Viz: Rose and Pink and one hog. except the Cow Rose and the hog which I bequeath unto my Sister Sarah Hughes. My Buggy, James Atherton undivided half of all the Lumber on the saw mill yard except such as may be required for repairs on said mill and which was sawed expressly for repairs on the mill. One promissory note given by Atherton and Fincher to me for the principal sum of fifty five (\$55.00) & 00/100 dollars dated 25th December 1875-
