Father James Henry, also his two beds and furniture together
with all other household furniture, and that to be made
as good and new when she come into my house, also her
bed and trundle and a good horse and ring, because
also a City Coventry born negro boy between the age of
Twelve & Twenty years the negro to be purchased out of
that part of my Estate willed to my two youngest daughters
and Fox Chen, within two years from my decease she
is to have a good house put in her possession until
the other is purchased and Reliance with her I also
give her two beds, I lend her the two east rooms of my
dwelling house with a small house next it, together with
that part of my plantation lying Easterly from the
house the above she have during her life or until another
other case if she should choose to give possession of the
house and plantation, she is to have thirty Dollars per
annum by my two youngest sons George and William
for the time a fore mentioned (5)

I give to my Daughter Cally Wells formerly Cally Gaddy,
and her children by Saml Gaddy a negro woman
named Peggy the children also a negro woman named
~~the~~ ^{increased} ~~her~~ ^{and five} ~~children~~ ^{children} ~~and five~~ ^{children} ~~children~~ ^{children}
being the whole of her Legacy --

I give to my son i.e. Abraham I want a negro woman
to be made in his possession and her children I give
to the children of my Daughter Mary, ~~the~~ ^{the} ~~children~~ ^{children}
I give Maudlin Lady Betty Lydia & John O. Chen

Wang her many Child becoming a man, she is to have
 one equal part of said Negroes with her Children
 The negroes to go into the possession of my two youngest
 Sons George & Jonathan and to remain there till the
 coming of age of the eldest of said Children
 then the negroes are to go into the possession of my

Executors and all the profits there arising from
 said Negroes is to be Distributed among the
 Children at the Discretion of my Executors at the
 coming of age of the eldest of said Children
 they are to have such negroes as my Executors
 may think proper and so at the coming of age of
 all said Children till the youngest one that she
 may or may have hereafter and then my will is
 that there be an equal Division of said Negroes
 agreeable to the Value of them when they received
 them I give my daughter Patsy, whether ^{she} single
 Patsy simply a Negro woman named Rachel and
 her Servant and five Shilling Sterling it being the
 whole of her Legacy

I give my Daughter Patsy wholly one Negro woman
 named Jenny & her Child and one Negro boy named
 Joseph
 I give to my son Joseph Heard a Negro boy named
 Isaac and one Negro Girl named Phill and her
 Servant and one hundred Shilling Sterling
 I give including whereon the same have already
 been set, I give to my son Thomas Heard one Negro
 woman named Lucy and her two children I give
 to my son Moses Heard a Negro woman named Sarah
 and David, also one hundred Shilling Sterling
 I give to my son Joseph Heard as all ready
 set out, I give to my son George Heard one Negro boy
 named Isaac and one Negro girl named Phill
 I give to my son Jonathan Heard one Negro boy named

The whole of my land including when I now live
 but not to have possession of that part till after
 for my wife until the & formentioned term
 Expires, I Give to my four sons Joseph Heard
 Thos. H. and George Heard & Paulthorn Heard
 all my State Prop. Counties and other Land
 warrants to be Equally divided according to
 Quality &

I also Give to my two youngest sons George and
 Paulthorn Heard all of my Estate not herebefore
 Willed, to be Equally Divided at my Decease or
 at the Coming of age of my youngest son Paulthorn
 Heard.

I do hereby appoint Abraham Heard Joseph
 Heard & Woodson Heard my lawful Executors
 of this my last will and Testament whereby
 whereof I have hereunto set my hand and seal
 this third Day of June Eighteen hundred and seven
