same my Soul to you who gave it do ordain this to be my last will and testa-  
ment in the distribution of my property as followeth to wit

I give and bequeath to my Son Walker Perkins one negro girl named Maria  
only her shall pay one hundred Dollars to the rest of my Debts debts  
I give and bequeath all the rest of my property together with the hundred  
Dollars from Walker Perkins to the four following Children of mine namely  
Rebecca Johnson, Ezekiel Perkins, William Perkins & Sally Cook to be equally  
divided this being my last will and Testament I have appointed my Son  
Walker Perkins to be my Executor In testimony whereof I have set my hand  
and Seal this twenty seventh day of December Eighteen hundred & Eighteen  
in the year of our Lord one thousand eight hundred and eighteen

gracious and unceasing Agency I have been supported and protected through life  
and my body I commit to its another earth requesting my executors hereafter named  
to cause the same to be interred in a decent manner.

Item I give and bequeath to my son Joshua Haughton a certain negro boy named  
Martin in addition to what I have heretofore given him which (said) first gift  
estimated to the value of the value of the negro herein given I have estimated at  
the value of one thousand eight hundred & fifty Dollars

Item I give and bequeath unto my son Ebenezer Haughton a certain negro man  
named Isaac in addition to what I have heretofore given to him both of which I have  
estimated at two thousand one hundred Dollars

Item I give and bequeath to my son John Haughton a negro girl named Lucy  
in addition to what I have heretofore given him both of which I have estimated  
at one thousand nine hundred & fifty Dollars
