 memory do hereby state my last will and testament and
 direct that my body be buried in a burial
 place suitable to me and my family.

I direct that all my just debts shall be paid
 and that all of the property I have
 at estate & personal property shall be
 paid to my heirs and assigns and that I have
 the power of giving all that they say in the
 above or secure, the same further down in the
 account of the day of sale and bond of giving
 to be sold and also the terms of sale.

I direct that my equal share be made of
 the money arising from the sale of the same property
 of mine I hereby bequeath and appoint my two sons
 Thomas Dillard & Samuel Dillard Executors of the
 last will and testament of this 28th day of
 June 1835
