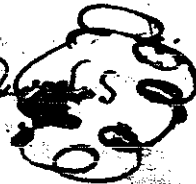

should my wife change her state by mar-
riage to the youngest Child arriving to the
age of twenty one years I wish a division
to take place in like manner as before mentioned
It is also my will that as my Children who
are here in after named (to wit; Abraham Ben-
dine Elisha Stephens Peggy Jackson John Barclay
Rhody Emily Frederick Allan Abel Washing-
ton) & should my wife be now pregnant
I wish the child to share equal with
the rest of my Children in my Estate
arriving to the age of twenty one years to
receive out of my Estate a proportionable share
at the discretion of my Executors having in
view an equal division among all my
Children bearing a supply for the main-
tenance and Education of the younger Chil-
dren without prejudicing their Claims in
said estate & I do here by Constitutes and
appoint Elyah Starry & James Guillen
Jrs. to be the sole Executors of this my
last will and testament signed sealed and
acknowledged in presence of by the sd.
Hendrick Davidson to be this last will
and Testament This twentieth day of
June in the year Eighteen hundred and
