Rebecca Brock & Hannah Brock My two daughters - My cows and Eashe to have and to hold for it know that Rebecca & Hannah My two daughters to have support on my plantation with their Mother while they continue as they are or single also I give the balance of my stock to be equally divided shall stand with all the Legacies - to be sold after my decease at a convenient time But I give my four sons Isaac John James & Reuben Before my time No 140 in the 2^d District in the above named County to be equally divided at my Wifes Decese or intermarriage the balance of my household and kitchen furniture the bay mare cow and calf to be equally divided with my five daughters at my wifes decese or intermarriage Also I leave my trusty friends Thomas Brock and George Brock my Executors to this will to collect and pay off my debts - And this to revoke and disannul all former wills by me made given under my Hand and seal this twenty sixth day of March one Thousand Eight hundred and thirty one - Signed sealed in pursue of
