my last will and Testament and first of
all I do hereby reserve unto myself
and my beloved wife Emma Mize
my lands on which we now live
with all its immunities during both of
our natural life times after our deaths
all of this my said lot or tract of
land which is situated lying
and being on the north west

116 Side of the Creek I do by these presents
Give and bequeath with all things pertaining
thereto unto my beloved Son Frederick
Mize and the remainder part of said
Lot or Tract of Land which is situate
on the South East Side of said Creek
from and after the same period of
time I do by these presents Give and
bequeath unto my two youngest Sons
(to wit) William D Mize and Littleton
which said Tract of Land shall be
equally divided according to quantity
and quality and I do further Give
and bequeath unto my aforesaid Sons
(to wit) Frederick William D & Littleton
one Good feather Bed and furniture
Each I also do Give and bequeath unto
my two youngest Sons William D &
Littleton Mizes one Cow a piece if
after our deaths there should be that
many left I further leave bequeath and Give
unto my youngest Son Littleton one Horse
at which which he is to receive at our
deaths and now have Given ordained
and bequeathed unto my three other
Children (to wit) Samuel Mize Lemmie
Harster Wife and Consort of Thomas
Harster and Sally Johnson wife and
Consort of David Johnson the sum
of five Dollars Each which said
sums of money is to be made out
of any ~~money~~ property which is not
herein mentioned and before bequeathed
and Given away but should there not be
a sufficient quantity of property left
at our deaths out of which to make
the said sum of money then and in

be bound after my death to pay over the
