constitute and appoint our trusty and worthy friend John
Harris of the County of Halifax and State of Virginia, our
true and lawful attorney for us and in our names to
view bargain sell and convey, all that tract of land
lying and being in the said County of Halifax known
by the name of Dawson's mill tract, a certain tract of
our said attorney concerning five hundred acres more or
less and for us and in our names to convey, deed receipt
receive to do and perform all and singular things or things
for us and in our names touching the same as fully thoroughly
and officially as if we ourselves were there and then
personally present - In witness whereof we have hereunto
set our hands and seals this 18th day of Sept 1798
