W. Watson his heirs & assigns forever in fee simple. And I the said Barton Watson for myself my heirs & assigns will warrant & forever defend unto the said B. W. Watson his heirs & assigns the title to the said Lot in the Town of Buchanan against the lawful claim or claims of all persons whatsoever.
