72 cents to my daughter Elizabeth Ann I give One
hundred and twenty two Dollars and 72 cents to my
daughter Martha Ann Bentley I give One hundred
and twenty two Dollars and 72 cents to my daughter
Isabella Ingram I give to her bodily heirs One
hundred and twenty two Dollars and 72 cents to my
son B. Kilgore I give One hundred and twenty
two Dollars and 72 cents to my son James F. Kilgore
to ~~Robert~~ I give One hundred and twenty two Dollars and 72 cents
to my son Francis M. Kilgore I give One hundred and
twenty two Dollars and 72 cents all of which I have
delivered to the above named heirs or their Agents
for which they will have no further claims on the
remaining portion of my Estate

I do hereby dispose of the remainder of my Estate as
